Go Paperless MPF Program

Environmental, Social and Governance and Carbon Neutrality have become international hot topics and they are integrating in our personal life gradually. Thus, it is imperative to save the Earth. Have you ever thought that managing MPF provides you an opportunity to make contributions to environmental protection and carbon reduction?

It used to be that printing and sending out 1 million sets of MPF Member Benefit Statement would consume about 4,000 trees¹, and these 4,000 trees could help the Earth absorb 88 tonnes of carbon dioxide every year². If you want to do your part to protect the Earth, please participate in Go Paperless MPF Program (the "Program") now!

From 1 December 2022 to 31 March 2023 (both dates inclusive) (the "Promotion Period"), if you meet the following specified requirements (including opting to receive the "Member Benefit Statement" by electronic communication means), Sun Life Hong Kong Limited ("Sun Life") will donate HK\$10 on your behalf to The Green Earth, a charitable environmental protection organization to support various types of environment protection and carbon reduction activities and projects. Further, you will be invited to register for an online seminar jointly organized by Sun Life and The Green Earth to learn more about environmental protection and low carbon living. The Program is subject to terms and conditions.

Specified requirements of the Go Paperless MPF Program:

- Download and register to use BestServe MPF mobile app ("Mobile App"); and
- Provide the updated email address and/or mobile number via the Mobile App to receive e-notifications on Member Benefit Statement; and
- ³ Opt for receiving regulatory notifications (i.e. including the Member Benefit Statement) by electronic communications via "My Information" under the Mobile App

Note: If you have already met the specified requirements 1 and 2 before the start date of the Promotion Period, you only need to meet the specified requirement 3 during the Promotion Period.

- ¹ The weight of a set of Member Benefit Statement is around 85g. 1 box of printing paper in A4 weights 12.5kg. It means that 1 box of printing paper in A4 can publish approximately 150 sets of Member Benefit Statement and the printing of 1 million sets of Member Benefit Statement consumes 6,666 boxes of printing paper. To produce a box of printing paper in A4, 0.6 of a tree with the height of 12 meters has to be cut. Therefore, the publication of 1 million sets of Member Benefit Statement consumes 4,000 trees.
- ² Each grown-up tree can absorb approximately 22kg of carbon dioxide per year. 4,000 trees can absorb around 88,000kg (i.e. 88 tonnes) of carbon dioxide.
